We are immensely grateful for your generous support of Northeast OKC Renaissance Inc. Your contribution has been instrumental in enabling us to not only uphold the successes of previous years but also extend our reach and impact within the Northeast OKC community.

In 2023, your support allowed us to achieve significant milestones:

- PlaceKeepers has flourished, having served two cohorts and completed four projects within the year. We are excited to have received a \$100,000 grant from Oklahoma County to create a PlaceKeepers Capstone Program.
- The OKC Minority Founder Accelerator (OMFA) was launched. OMFA is a 16-week experience designed to accelerate OKC's minority entrepreneurship ecosystem by investing in founder development and transforming high growth and lifestyle (or "main street") business concepts with potential. Our inaugural cohort was comprised of 10 businesses. Upon successful completion of the program, each founder had the opportunity to be granted between \$10,000 and \$20,000.
- We secured two significant grants which allowed us to begin capacity building as well as embark on the process of initiating a revolving loan fund in the near future.
- organizations and initiatives have been fruitful. Our involvement in the H.B. Foster Center for Minority Entrepreneurship Development project has been significant. We've actively contributed to reimagining this historic community center as an entrepreneurship hub. We are delighted to be in a collaborative partnership with the NEOKC Neighborhood Association Coalition. As a supporter of the coalition's efforts, NEOKCR financially supported an AmeriCorps capacity builder to serve their organization's needs. The Northeast OKC Nonprofit Incubator has been a fantastic addition to the Northeast OKC (NEOKC) ecosystem, and we are happy to have been a physical sponsor of the program.

Community Collaboration Space.

We are excited to announce that we will be moving into a new Community Collaboration Space. This space will serve as a beacon of hope and unity for community members and allies alike, providing a platform for cooperative innovation to create positive change. We invite you to join us as thought partners in shaping the future of NEOKC.

PlaceKeepers

July will bring our Minority Developers Conference, and will have the theme "Community Catalyst." The conference will feature plenary and breakout sessions from the nations top thought leaders covering topics ranging from ethical design, cooperative economics, and community stewardship.

Our Capstone will also be launched this coming summer. Research has shown that one of minorities largest hurdles are balance sheet fractures. Factors such as credit score, savings and net worth hinder them from even pitching a project. The Capstone Program allows NEOKCR to be a lead developer and create a co-development team out of PlaceKeepers who are experiencing a shortfall. NEOKCR will partner with Oklahoma City Urban Renewal and Oklahoma City Housing Authority to build on vacant OCURA lots throughout NEOKC. PlaceKeepers will work with one of NEOKCR's partner banks to create a financial plan which will serve as the launching pad to becoming an independent developer. Each participant will invest and receive equity in the project. We intend to sell all of our homes affordably to community members and stakeholders between 80 - 120% of Area Median Income.

OMFA

An additional three cohorts will have been served by the end of 2024, bringing the total number of businesses served to more than 40.

Establishment of a Small Business Revolving Loan Fund.

We are working to launch a dedicated fund to provide accessible financing options for aspiring entrepreneurs, fostering economic growth and sustainability within the community.






